Job Description

Depository Accountant

Reports to Depository Manager

The purpose of this position is to contribute to the delivery of the routine day-to-day depository functions to a portfolio of Luxembourg clients, under the direction of a Depository Manager.

Key responsibilities:

- + Deliver the daily cash monitoring and reconciliation obligations for a small but growing portfolio of depository clients, including working with a small team and the client to source relevant documentation supporting any cash flow activity observed
- + With the support of your small team, collate documentation from internal and external sources that supports our clients' fund investment activity both as it occurs and for periodic reconfirmations
- + Maintain accurate fund accounting records on eFront and fund documentation records on SharePoint
